- 1. Since I have only one car and have signed up for a Ordinary Membership, do I have to take up the bonus AA Family Membership for my spouse?**
AA Membership is personal and tagged to the Member as an individual, and not to the vehicle. When you sign up for the bonus AA Family Membership for your spouse, your spouse will be a Member and he/she will be able to access our benefits and privileges, such as calling AA's 24-hour Roadside Assistance Services (RAS) even when you are not available
- 2. I do not have a spouse. Can I sign up my sibling, who is also a driver, for the bonus free 3-year AA Family Membership?**
The AA Family Membership is open to spouse or children below 21 years old of a Ordinary Member. The AA Family Membership is not applicable for siblings or parents of the Ordinary Member.
- 3. My child is 19 years old,an I sign up him/her up for the bonus 3-year AA Family Membership?**
As AA Family Membership is open to children below 21 years old, thus, they can enjoy a maximum of 2 years of the AA Membership.
- 4. Can I take up the bonus free 3-year AA Family Membership at a later date?**
To be eligible for the bonus free 3-year AA Family Membership, your spouse or child below 21 years old must register for the membership by 26 Feb 2021.
- 5. The bonus AA Family Membership does not benefit me. Can you convert the bonus AA Family Membership to rebate or vouchers?**
The bonus AA Family Membership cannot be exchanged or converted to rebate or vouchers.
